- III. **Acceptance of Agenda** Mr. Tyler made a motion to approve the agenda. Mrs. Blakely seconded, and the agenda was unanimously accepted.
- IV. **Approval of Minutes** Mr. Sauer made a motion to approve the minutes with technical corrections. Mr. Tyler seconded and the minutes from the November meeting were unanimously approved.

- VI. Reporting
 - A. **Home and School:** Mr. Tyler reported that Home and School has held two meetings to date with the budget being finalized at the last meeting. The Home & School Auction already has \$6,500 in funding.
 - B. Administrator's Report: A written report was submitted. Teachers spent October 16th reviewing data from fall screening assessments. These assessments act as an early warning system to address any learning gaps and are only the first step in evaluating student achievement data. They are not meant to be stand alone achievement tests. If teachers see concerns on the screening assessments, they consider all assessments and student work they have and if necessary, implement an intervention targeted to the student's needs. Both MAP and FAST tests will be given three times a year. This allows for closer monitoring of student growth. Parent reports are being prepared and will be sent home before the end of the month.

The increased movement between in person and distance learning was anticipated. The record keeping, communication, documentation, and work with state and county health requirements keeps everyone in the office very busy. Teachers are managing the changes and requirements of running both in person and distance learning programs with great stamina and resilience.

With fall sports underway, there are reports of student COVID-19 exposure on their teams or during weekend activities. Ms. Kever asks parents and coaches to please take extreme caution with evening and weekend activities. Once a student is exposed from an outside environment, it often results in exposure and quarantine for classmates and teachers. Ms. Kever said, "We can only control what we do within our schools, we cannot control what is coming into our buildings."

Ms. Kever reported that as of November 3rd, enrollment was 367 with 29 online students.

C. **Pastor's Report:** Father Dave shared that the 8:15 am Mass on December 8th for the Feast of the Immaculate Conception will be livestreamed in classrooms.

Father also said that there is discussion regarding suspension of sports through November.

The capital campaign will launch at Masses this weekend and will continue through January 1, 2021.
