- III. **Acceptance of Agenda** Mr. Hayes made a motion to approve the agenda with the addition of Executive Session after Wrap-up. Mrs. Johnson seconded, and the agenda was approved with the change.
- IV. **Approval of Minutes** Mrs. Johnson made a motion to approve the minutes with the proposed technical changes. Mr. Hayes seconded, and the minutes from the March meeting were unanimously approved.

VI. Reporting

A. **Teacher Representatives:** Ms. Rosebeck's First Grade students are working toward reading at level J or beyond by the end of the year. The readers club is starting tomorrow. In math, the students are learning to tell time. They are also focusing on Lent and the meaning of Easter.

Ms. Walter teaches Band. Students recently participated in a solo ensemble contest and did very well. The students are preparing for the spring concert which will be held on May 21, 2019. She is also the assistant director of the Middle School musical, *The Music Man*, which will be held on May 14, 2019. She teaches 27 students in Middle School band and 19 students from 5th grade.

Mr. Caffrey teaches Technology to all grades. They are using the new STEM Lab purchases made with last year's auction funds. The students are working with snap circuits, Spheros, invention kits, design and coding.

B. **Administrator's Report:** A written report was submitted. Ms. Kever said the administrative team has been focusing on enrollment this week because the CTO deadline is tomorrow. They are reaching out to families that have previously applied for CTO to see if they need assistance with the application. Enrollment is currently at 44 in Preschool and 266 K-8. 39 current students have not enrolled.

In staffing news, the new Kindergarten teachers should be announced within the week. Applications for the P.E. position are still being reviewed.

The last day of school programming will be changing. It will begin with an end of school mass involving all classes. Following mass, the new Middle School (current 5-7 grades) will gather for a scholarship and awards reception, while the younger grades will remain in their classrooms for a more personal send off.

Advanced Ed is asking for parents to interview as part of the engagement review team.

C. **Pastor's Report:** Father Fleming said the school Reconciliation went well and was completed within two hours with so many priests available to help. The Good Friday school liturgy is being planned. The planning for the end of school mass is underway. Updates on the capital campaign include negotiating the contract with the architectural firm and letters have gone out to fundraising consulting companies.

The motion was seconded by Mrs. Johnson. The motion passed unanimously.
