  - B. Administrator's Report: A written report was submitted. Ms. Kever talked about the Pius Pals summer program opening on June 15<sup>th</sup> and discussed how Mrs. Baker has been working with DHS, IDH, and CDC to ensure adherence to all current recommendations and guidelines are being met. There was some discussion on what preparations are being made in the school building for the students to return and some of the different scenarios involved with the State required Return to Learn Program. Enrollment is currently at 335 PK-8 with 12 current students not enrolled. Due to the COVID-19 pandemic, families are expressing some uncertainty about what the next school year will bring. There were some questions regarding what bus service may look like for St. Pius X students in 2020-2021, but nothing is certain at this point and Ms. Kever and Mr. Baranosky continue to work with the Urbandale School District and Durham Bus Company as the situation is everchanging. Along with everything else, Mr. Baranosky has been working diligently on a new St. Pius X video he will share a preview with the Board members!
